Global Command and Control System - Joint (GCCS-J) Cloud is an enterprise, cloud hosted system that provides web client access to the C2 capabilities provided by local GCCS-J 6.x sites. GCCS-J is the Department of Defense system of record for Joint C2, and supports joint and multi-national operations. GCCS-J provides a Common Operational Picture (COP) via an investigation near-real-time picture of the battlespace with ground, air, maritime, and space tracks for US, coalition, and enemy forces. The GCCS-J Cloud infrastructure is based on modern COTS and open source products, and the numerous C2 capabilities within the GCCS-J Cloud are provided via various GOTS applications. The types of personal information about individuals that is collected includes: Name(s), DoD ID Number, Organization, Security Information, Official Duty Telephone Phone, and Work E-mail Address.
