c. Describe the purpose of this DoD information system or electronic collection and describe the types of personal information about individuals collected in the system.

The National Background Investigation Services (NBIS) Investigation Management (IM) component will interface with one or more external systems that will conduct automated record checks (ARC). The ARC will supply selected investigative items to the IM. For NBIS IM MVP, the only investigative items supported by ARC are the credit check and the Financial Crimes Enforcement Network (FNCN) check. The ARC suppliers will interface with official government agencies and commercial entities to obtain information. These interactions between the ARC supplier and its information sources are the responsibility of the ARC service provider and are out of NBIS IM scope. The IM system will send requests for investigative items to ARC suppliers using controlled interfaces. NBIS will format the request data, and accept the response data, according to the ARC supplier's specifications. The only ARC supplier in scope for NBIS MVP is the Defense Manpower Data Center's (DMDC) Mirador system. Refer to the NBIS-Mirador Interface Control Document (ICD) for specification of this interface. Any ARC investigative items not supported by Mirador at NBIS IM MVP deployment are out of scope.

d. Why is the PII collected and/or what is the intended use of the PII? (e.g., verification, identification, authentication, data matching, mission-related use, administrative use)

IM is an automated system that houses the Security/Suitability Investigations Index (SII) and is used for the automated entry, scheduling, case control and closing of background investigations. SII is the repository of personnel investigations conducted by OPM and other authorized agencies. IM uses information from the SII to support the process of conducting investigations and to facilitate reciprocity. The need for reciprocity and processing includes: data-entry of security questionnaire information on individuals who are being investigated; automated scheduling of National Agency Checks (NACs) at the Federal Bureau of Investigation (FBI), Department of Defense Central Index of Investigations (DCII), national credit bureaus, and various other sources necessary for a complete investigation. IM facilitates scheduling and transmitting investigation requests to investigators, receiving reports of investigation from investigators, closing investigations, and transmitting results electronically to customer agencies.
